## Healthy Mothers, Happy Babies

Dear Friends:

In keeping with our holiday tradition, Noelke English Maples St. Leger is once again offering to match year-end charitable gifts to **People's Community Clinic** to help our low-income neighbors.

We support People's Community Clinic (PCC) because it is a critical provider of affordable health care to over 11,000 of our uninsured and "working poor" neighbors in Austin. For the seventh year in a row, we hope to raise at least \$10,000 for PCC during the holiday season — a goal that friends and associates have helped us exceed in some years.



This year we are raising funds to support the clinic's "Healthy Mothers, Happy Babies" project. This important project is focused on ensuring excellent birth outcomes for expectant mothers and a healthy start in life for their newborns. Throughout pregnancy, prenatal patients receive a continuous course of care that includes medical assessment, health and nutrition education, fetal monitoring, laboratory tests, vitamins, and social services. Infants born to PCC's expectant mothers are welcomed into the Clinic's Pediatric Program, which provides well-child exams, immunizations, developmental screening, and guidance for parents, improving the lives of these young patients and strengthening families.

As a fundraising challenge, Noelke English Maples St. Leger is pledging up to \$5,000 in matching funds for all donations made through us to PCC by Dec. 31. Our matching funds mean that twice as many neighbors in need will benefit from your tax-deductible gift.

To participate, please send your contribution, payable to People's Community Clinic, to our office. We will match checks received **by December 31st** and deliver the funds raised to PCC. You or your firm will receive a letter of gratitude and acknowledgement directly from PCC.
